Use this form to request a noncertified (informational only) Minnesota birth record on plain paper. *It's illegal to give false information to obtain a vital record, and it may subject you to fines, jail time, or both.*

Records of children born to married parents are “public”; anyone can buy a noncertified **public** birth record. Records of children born to single mothers are “confidential” unless the mother chose to make the record public.

- I want an image of the paper record for a birth in 2000 or before.
- I want a printout of a birth record that includes the subject’s name, date and place of birth, and the names of the subject’s parents. The printout *does not show* health information.
- Birth records of children born to unmarried mothers are confidential unless the unmarried mother chose to make the record public at the time of birth. The persons listed below are eligible to buy noncertified **confidential** birth records. **Check one box:**
