 - A) **2025 Road Construction update**-Northern Natural Gas pipeline project affects 3 township roads, 330th St E of Hwy 13, 340th St at the City of Montgomery Waste Treatment Plant, and Pepin Lake Road. There is \$10,000 in an escrow account for repair of those roads. The township called in the LeSueur County Hwy engineer, Dave Tiegs to give us an estimate to return the road to pre-construction condition. NNGas will be asked to add to the escrow account \$37,740. The final repair will be done in the spring of 2026 after the thaw.

 - C) **Rolling Meadows culvert repair** – there were 2 bids for the repair. Motion by Tony second by Chris to accept the bid from Braith Excavating for \$3800 to clean the culvert. Motion carries 3-0
